1. LANDFILL POLICIES AND PROCEDURES. User agrees to comply with PVT's Landfill Policies and Procedures which are available for inspection on PVT's website (www.pvtland.com) and at PVT's offices. User acknowledges that PVT's Policies and Procedures may be changed by PVT without notice. Failure to comply with these Policies and Procedures may result in the denial of acceptance for disposal at the landfill.

2. ADDITIONAL SERVICES. As set forth in PVT's Policies and Procedures, drivers are required to unload their loads at the landfill as directed by spotters or other PVT employees. If a driver is unable to unload debris from the truck, trailer or bin, PVT may in its sole discretion assist with the removal of debris from the truck, trailer or bin subject to the terms and conditions of this Additional Services Agreement. PVT may provide other additional services at its sole discretion subject to the terms and conditions of this Additional Services Agreement.

3. RATES. The rates and charges for additional services are available for inspection on PVT's website (www.pvtland.com) or at PVT's office. User acknowledges that these rates and charges are subject to change by PVT without notice.

4. RELEASE. User hereby releases and waives, absolutely and forever, any and all claims, demands, rights of action, litigation, damages or liabilities, including attorney's fees and costs ("Claims"), against PVT, its managers, officers, directors, agents, representatives, employees, and their respective successors, subsidiaries, affiliates and assigns ("Released Parties") arising out of, or relating to or connected in any way with, directly or indirectly, this agreement, including but not limited to any damage to User's vehicle or equipment. User acknowledges and agrees that this Additional Services Agreement has been entered into without reliance upon any statement, representation or promise from PVT. User understands and agrees that this is a full and final release of all past, present or future Claims, known or unknown, arising out of the additional services provided by PVT.

5. INDEMNIFICATION. User hereby agrees to indemnify, defend and hold PVT, its parent and affiliate companies as well as any and all directors, officers, employees, attorneys and agents thereof, harmless against and from and will reimburse PVT in respect of any and all Claims arising directly or indirectly, in whole or in part, out of the additional services provided by PVT or any breach of this Agreement. User, upon notice from PVT, agrees to defend any such Claim using counsel reasonably satisfactory to PVT.

6. SURVIVAL OF OBLIGATIONS. User's obligations of Release and Indemnification shall be enforceable and remain in force and effect during the duration of this Additional Services Agreement and shall continue and remain in force and effect after the termination of this Additional Services Agreement.
